**1      To receive apologies for absence and to approve reasons for absence.**

**4      Reports from County and District Councillors.**

District Cllr Pam Cumming reported the following.

- The SWDP review is available for public consultation and comments can be submitted by 13<sup>th</sup> December 2022. Increased number of river crossings have not been included and road infrastructure is unaltered despite increased housing

- The glass bottle collection at Curradine Barns is to cease when a new site is found.
